Ways to Get Involved

Communications:

Leadership Opportunities

The LCLD Fellows Alumni network is led by an Executive Council (EC) and the subcommittees listed below. Subcommittee chairs sit on the EC, which is run by the Fellows Alumni Executive Council Chair. A Secretary, Treasurer, and Historian also sit on the EC. Contact information for Fellows Alumni committee chairs can be found at www.lclldnet.org/fellows/alumni-leadership/.

Advocacy Group Committee:

The Advocacy Group Committee is responsible for planning, implementing, and supporting the Advocacy Group Program, a mutual support system where participating Alumni are divided into small groups and actively promote each other's careers. Through the Advocacy Group Program, Alumni assist each other in reaching their career goals through concrete steps, including providing feedback to each other on career strategy, sharing learning resources, and introducing each other to people who can be critical to career transitions or progressions.

Alumni Conference Committee:

The Alumni Conference Committee is responsible for planning and implementing the annual Fellows Alumni Conference, with the support of LCLD staff. The committee's responsibilities include (1) developing a conference agenda and conference sessions, (2) establishing and maintaining a conference budget, (3) identifying and confirming guest speakers, (4) organizing social events, and (5) securing sponsorships to cover the costs of the conference.

Communications Committee:

The Communications Committee is responsible for building effective and ongoing relationships with and among Alumni by keeping them informed of, and connected to, the Alumni experience. This committee works closely with the professional communications staff of LCLD.

Outreach Committee:

The Outreach Committee creates opportunities for Alumni to support their local communities. The committee's responsibilities include (1) organizing a yearly community service project at the Fellows Alumni Conference, (2) identifying volunteer opportunities, (3) providing an online list of mentoring programs and opportunities, (4) organizing an annual fundraising event for charity, and (5) fostering an environment in which Alumni share and exchange their personal stories of community service and impact.

Program Development Committee:

The Program Development Committee is responsible for promoting engagement among LCLD Members, Fellows, and Fellows Alumni by developing substantive programming and organizing: (1) roundtable discussions, (2) networking events, (3) graduation events, and (4) get-togethers in connection with Leadership Lunches and Learning Experiences. The committee also organizes Success in Law School Group Mentoring events and facilitates 1L LCLD Scholars Program networking events in participating cities.
