JOE CONROY is Chief Executive Officer of Cooley and a member of the firm's management committee. He is based in Cooley's New York office. SEAN EDGETT is the Interim General Counsel at Twitter. Prior to this role, Edgett served as the Vice President and Deputy General Counsel, and he has been at Twitter for more than five years. Prior to Twitter, he was the director of legal at NetApp, and an associate at Latham & Watkins and Akin Gump Strauss Hauer & Feld LLP.

Edgett earned his Juris Doctor from Pepperdine Law and a Bachelor of Arts degree in cognitive science and psychology from the University of California at San Diego.



MATT HECKMAN serves as the Director and Associate General Counsel of Media, Live Video, and Marketing at Twitter, having served in progressively responsible positions at the company since 2013.

Prior to joining Twitter, Heckman was senior counsel of Internet Services—iTunes at Apple, an associate in the Entertainment Group at Greenberg Traurig LLP, and director of business and legal affairs at Warner Bros. Records. Prior to working at Warner Bros. Records, Heckman was an entertainment associate, with music focus at Roberts & Ritholz, LLP, and with a focus in film and television at Epstein, Levinsohn, Bodine, Hurwitz & Weinstein, LLP and Irell & Manella.

Heckman earned his Juris Doctor *cum laude* from Harvard Law School, where he was the executive editor of *Harvard Civil Rights-Civil Liberties Law Review*. He earned his Bachelor of Arts degree *summa cum laude* in English, with a minor in music/fine arts, from Georgetown University. At Georgetown, Heckman served as president and vice president, and played lead alto saxophone in the Georgetown Jazz Band.



MICHELE LEE recently became the Associate General Counsel and Head of Litigation and Competition at Twitter. Previously, she had been associate legal director of U.S. Litigation and Global Competition since 2015.
