**ELLEN MORAN DWYER** is Managing Partner of Crowell & Moring LLP, and a member of the firm's Labor & Employment Group. As Managing Partner, Dwyer is responsible for the overall operation of the firm's U.S. and foreign offices. In 2012, *Law360* named Dwyer in its "List of Most Innovative Managing Partners," and in 2014, *Law360* ranked Dwyer among its "Female Power Brokers."

In addition to her management responsibilities, Dwyer maintains an active labor and employment practice representing employers in a full array of labor and employment matters, including class action and individual claims filed under federal and state anti-discrimination and related employment laws.

Prior to his role as General Counsel, Schultz was the Deputy General Counsel for Litigation, Investigations, and Global Functions, where he managed all major litigation filed against HP globally, including all intellectual property, government investigations, and commercial and employment disputes.
