TOM CABANISS has been Managing Partner of McGuireWoods LLP since 2007. He currently devotes most of his time and energy to managing the law firm. As Managing Partner, he has been the firm's representative to LCLD since its inception. He practices in the areas of real estate and commercial lending, banking, and creditors' rights with an emphasis on bankruptcy, commercial workouts, and real estate workouts.

Cabaniss has been selected for inclusion in *The Best Lawyers in America* from 1995-2015 in the areas of Bankruptcy and Creditor Debtor Rights and Insolvency and Reorganization Law. He is admitted to practice in Virginia and North Carolina, and before the U.S. Bankruptcy Court, U.S. Court of Appeals for the Fourth Circuit, U.S. Federal Court, and U.S. Supreme Court. He is also a Registered Foreign Lawyer in England and Wales.

Cabaniss earned his J.D. from the University of Virginia School of Law. While earning his undergraduate degree in industrial engineering from North Carolina State University, he was honored as a member of both Phi Kappa Phi and Tau Beta Phi.

Miller has more than 25 years of legal experience focused on the financial services industry, including significant stints at Bank of

America, in government, and private practice at national law firms.

Miller represents Bank of America in a number of trade associations and industry groups. He is active in The Clearing House Association Managing Board, a member of the Board of Directors of the ABA Securities Association, and a member of the Executive Committee of the SIFMA Compliance & Legal Society.

From 2004-2010 Miller was head of the Legal Department’s Regulatory Inquiries Group (“RIG”), a group with enterprise-wide responsibility for leading the bank’s response to governmental inquiries that pose significant legal, economic, or reputational risk.

Prior to joining Bank of America, Miller was a trial lawyer in the Division of Enforcement of the Securities and Exchange Commission (SEC) in Washington, D.C. In that capacity he successfully prosecuted cases of national significance involving insider trading, market manipulation, financial and accounting fraud, Ponzi schemes, broker-dealer issues, failures to supervise, and offshore funds. He also worked extensively with criminal investigators and prosecutors in parallel proceedings. Before joining the SEC, Miller was a litigator for 11 years at Rogers & Wells in New York, NY, and Steptoe & Johnson LLP in Washington, D.C.

Miller obtained his B.A. from Cornell University’s College of Arts and Sciences and his J.D. from the Albany Law School of Union University.

Miller is also active in the Charlotte community. He serves on the Mecklenburg County Bar’s Diversity & Inclusion Committee, and is a member of the Board of Trustees of the Charlotte Preparatory School.
